Report from April 1st, 2020 to March 31st, 2021

# **Community Support Services Department Report**

We offer a range of programs and services for seniors and physically disabled adults living in the District of Timiskaming. This year, we helped over 1,500 seniors and physically disabled adults through one or a combination of the following programs:

Meals on WheelsDiners ClubTransportationAdult DayStand UpHome HelpAssisted LivingEmergency ResponseSocial VisitingAttendant OutreachSupportive Housing

Post Stroke Recovery Program - in partnership with ICAN
Patient Assisted Transfer to Home (P.A.T.H) - in partnership with Red Cross
Low Acuity - in partnership with ICAN
Peer Support - in partnership with ICAN

The 2020-2021 year has been a time of goal reaching for our key programs. Dorothy Malinowski, Food Services Team Lead along with a committed team of continue to

provide nutritious and well-balanced frozen meals to our seniors and physically disabled adults all made from the new Timiskaming Home Support Meals on Wheels commercial kitchen. A big thank you to the City of Temiskaming Shores for giving us exclusive rights to utilize the "Lion's Den" while we waited to move into our newly renovated kitchen. We continue to meet our goals in serving 20,000 meals this year, consistent with the established benchmark over the last year. During the pandemic, THS also received



funding from OCSP to expand on food services. A big thank you to the association!



Our Transportation Program drivers safely delivered essential trips to medical appointments to ensure the seniors and physically disabled adults within the district remained in their homes. Amidst COVID, THS was able to isolate many of the clients by having the same driver assigned to them. This is something that rarely occurs with public transportation or taxis. Crystal Paige, Transportation Team Lead along with her team continue to bring her enthusiasm and resilience to the program which translates to quality service delivery.

Melanie McLean, THS' Adult Day Team Lead continues to promote the Adult Day



program across the District of Timiskaming and enhances the program based on client feedback. The program has increased its roster of individuals served over the last year due to the pandemic. Melanie has continues to connect with eligible individuals through the Seniors Centre Without Walls program. There is, however, a strong enthusiasm for face-to-face visits; in fact, THS managed to safely deploy staff in-home to offer Adult Day Services to the most vulnerable clients. We have enhanced and

increased the variety of activities in the program to include more guest speakers and a variety of creative entertainment avenues. The clients enjoy them immensely.



# **Volunteer Services Report**

While volunteering has been on hold over the last year, Amanda Breault, THS' newest Volunteer and Marketing Team Lead is excited to introduce a volunteer recruitment program. THS has very slowly started to reintegrate volunteers into operations with the same momentum as the province's reopening initiatives.
